#### Course overview

### **Emergency Ethics and Politics**

Emergency has both meta-ethical and normative ethical aspects. Emergencies are often thought to create exceptions to moral precepts and moral precepts are sometimes claimed (e.g. by Kant) to be exceptionless. Among the normative ethical aspects of emergencies are the overridingness of the obligation to curtail or prevent them and (differently) the urgency of addressing them when they are imminent. Large-scale emergencies are sometimes associated in both theory and practice with chaos and with a loss of inhibitions corresponding to moral prohibitions. The point of politics is sometimes tied to the need to prevent or escape this chaos. A state of nature in which everything is permitted that is sincerely thought to aid anyone's prosperity or survival is such a chaos. According to Hobbes, the whole purpose of government is permanently to pre-empt such chaos. In this sense politics is pre-eminently emergency politics. Even though this view is incorrect, there is something to be learned from Hobbes, and from the neo-Hobbesianism of Schmitt. Both point to the importance of security-preserving political forms even in time when the effectiveness of those forms makes worries about security appear out of order. Although security matters enormously, it is not quite the organizing value that Hobbes thought it was. Nevertheless, there is a way of reconciling the importance of security with something that genuinely does have the status of organizing value—namely, freedom. The preferred reconciliation is not communitarian, and communitarian understandings of security and supreme emergency – such as Walzer's (and Schmitt's)-are to be rejected.
