Course description:

Ludwig Wittgenstein is widely regarded as one of the most important philosophers in the twentieth century. His early philosophy, represented by his *Tractatus Logico-Philosophicus*, has influenced important philosophical schools in the early twentieth century, including that of the Vienna Circle. His later philosophy, to be found in his posthumously published book *Philosophical Investigations* (amongst his many writings, all unpublished during his lifetime), also influenced many prominent philosophical trends, including that of the Ordinary Language School. Nevertheless, Wittgenstein's philosophy has intrinsic values and importance in itself. This course aims to introduce Wittgenstein's philosophy presented in the *Philosophical Investigations*. It is intended to be a guided study of at least the first part of the *Philosophical Investigations* up to the entry PI 307.

Learning outcomes:

After taking this course, students should able to:

- understand the key concepts, major issues and prominent theses and positions in the first part of Wittgenstein's *Philosophical Investigations*.
- critically discuss and evaluate the major issues and positions in the first part of Wittgenstein's *Philosophical Investigations*.
- appreciate the main concerns and the nature of some of the major issues in Wittgenstein's later Philosophy.
- acquire skills in argumentative discussion and in writing about issues in Wittgenstein's Philosophy.

Learning activities:

Learning activities of this course include lectures, tutorials, reading essays, and writing a term paper:

Students should be able to develop and enhance their analytical and argumentative skills through discussion in tutorials and lectures, and writing the term paper.
